



## SARGASSUM INFLUX CHAMPIONS: Civil Society on the frontline

### KEY MESSAGES:

- The sargassum crisis is likely to continue into the unforeseen future.
- Responses to addressing the issue have generally been reactive rather than proactive.
- Significant gaps remain in information and understanding, as well as effectiveness of response strategies.
- There is general consensus that part of the response should consider influxes an economic opportunity as much as a threat.
- The arena is now very dynamic with the entry of many players with varying, sometimes competing interests.
- No formal attempt has been made to explore opportunities for promoting synergies to avoid unnecessary duplication.

Civil society organisations (CSOs) have an important role to play in:

- Shifting mindsets to view sargassum as an opportunity rather than a threat.
- Supporting the science-policy interface through research and development initiatives.
- Advancing innovation in the development of cutting edge technology to promote effective clean-up/harvest operations.
- Fostering innovation in the development of sargassum uses.
- Advocating for a harmonised regulatory framework to support sargassum product development.

This summary document is based on the updated UNEP-CEP Sargassum White Paper. The brief:

- Provides key messages that highlight the complexity of the sargassum crisis in the region.
- Details the role civil society can play in addressing the sargassum issue and exploring opportunities.
- Outlines notable ongoing initiatives being championed by civil society organisations (CSOs) in the Caribbean.
- Highlights important civil society players in the Caribbean region.
- Presents priority actions for CSOs aimed at supporting adaption and resilience to this phenomenon.

## Policy Actions

-  Employ innovative communication tools to raise the awareness of the general public and shift mindsets to view sargassum as an opportunity.
-  Advocate for public-private partnerships to support applied research for sargassum product development.
-  Promote synergies between existing initiatives to avoid duplication.
-  Address disconnects and gaps in coordination and collaboration through networking and improved inter-sectoral linkages.
-  Advocate for sargassum-specific policies, protocols and standards to support sustainable sargassum-related businesses and protect public and environmental health.
